## GOOD ACADMIC RECORD

Good academic record means at least Ilnd Division either at secondary or Sr: Secondary / Higher Secondary level and at graduate level.

1. A relaxation of $5 \%$ will be given at the graduate and master's lovel for the Scheduled Caste/Scheduled Tribe/Differently-abled (Physically and visually/differently-abled) categories for the purpose of eligibility and for assessing good academic record during direel recruitment to teaching positions. The eligibility marks of $55 \%$ markis (or an equivalent grade in a point scale wherever grading systom in followed) and the relaxation of $5 \%$ to the categories menllonod above are permissible, based on only the qualifying marks withoul including any grace mark.
2. A relaxation of $5 \%$ may be provided, from $55 \%$ to $50 \%$ of the marks to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.

## SEVEN POINTS SCALE:
