1. In the Faculty of Engineering and Architecture, currently following UG/PG course are running under self finance scheme (SFS):

i.	B.E (Electronics & Computer Engineering)	(60 seats)
ii	B.E (Electronics & Electrical Engineering)	(60 seats)
iii.	B.E (Information Technology)	(30 seats)
W.	B.E (Building & Construction Technology)	(60 seats)

In this connection I would like to bring to you kind notice that in the above courses, there is no permanent sanctioned posts given by the University and State Government. Therefore these courses are currently run by employing Guest Faculty as per norms issued by the university.

These Guest faculty members just engage classes but they are not useful for the development of laboratory work and other activities of the department. Further many of these faculty members discontinue some times during the semester or at the end of the semester. This creates a lot of inconvience in having a smooth functioning of the classes. Thus it is proposed that in SFS courses. Guest faculty on contract basis for fixed period of time and at fixed Honorarium may be empanelled.

2. Assessment of total work load:

There shall be committee for each department to examine the workload. The Head of the department concerned shall present the details of the workload to the committee in the prescribed format. The committee after reviewing the details will finalize the same. The recommendation of the committee will be submitted to the Vice-Chancellor.

The composition of the committee will be as under:

- 3. Rates for conducting term end practical examinations/term end examinations in Sessional shall be the same as that for laboratory classes, if assignment is made on per hour basis. In the case of fixed remuneration per month basis, all such works, mid term tests, evaluation of mid term tests and end term Sessional / Practical answer books and other associated laboratory and Departmental works shall be part of the job.
- 4. For mid term test of one hour duration, payment to the assignee taken on 'per hour basis', shall be equal to a lecture of one period No extra payment shall be admissible for evaluation of the answer books of mid term, test, it shall be considered part of the mid term test.
- Evaluation of laboratory assignments / Sessional / Practical's is part of class itself and no separate payment shall be made for the same.
- The working load will be assigned semester wise and the assignment may be terminated at any time by the respective Head of Departments without any prior notice or information.
